MODERNISATION FUND **EIB CONFIRMATION OF PRIORITY INVESTMENT**

ref. MF 2022-2 CZ 0-003

Beneficiary Member State: Czech Republic

Investment Proposal: Financial instrument for improving energy efficiency in business (ENERG Programme).

1. Background

The Modernisation Fund was set up pursuant to Article 10d of Directive 2003/87/EC of the European Parliament and of the Council of 13 October 2003 establishing a system for greenhouse gas emission allowance trading within the Union and amending Council Directive 96/61/EC (the “ETS Directive”).

The legal basis for the operation of the Modernisation Fund is set out in the Commission Implementing Regulation (EU) 2020/1001 of 9 July 2020 laying down detailed rules for the application of Directive 2003/87/EC of the European Parliament and of the Council as regards the operation of the Modernisation Fund supporting investments to modernise the energy systems and to improve energy efficiency of certain Member States (the “Implementing Regulation”).

In accordance with Article 10d(6) of the ETS Directive, the European Investment Bank (the “EIB”) is to confirm whether a proposed investment falls into a priority area. The EIB may confirm the proposal as a priority investment if the conditions specified in Article 6(7) of the Implementing Regulation are met.

2. Investment proposal

Pursuant to Article 4(1) of the Implementing Regulation, on 13/09/2022, Czech Republic (the “beneficiary Member State”) submitted to the EIB an investment proposal “Financial instrument for improving energy efficiency in business (ENERG Programme)” for which it envisages a contribution from the Modernisation Fund (Modernisation Fund reference number MF 2022-2 CZ 0-003).

The scheme will support measures to increase energy efficiency in business where the recipients of support will be business entities outside of the EU ETS system.

The supported measures fall under the following categories:

- Measures in the energy management of enterprises (renewable energy installations, modernisation and reconstruction of energy production equipment, energy management systems, modernisation of lighting systems and the use of waste heat).
- Energy reduction in buildings (insulation and other construction measures that can reduce energy losses, improvement in energy efficiency of technical and improvements in building control).
- Application of hydrogen from renewable sources (in compliance with the EU delegated acts applicable to renewable hydrogen)

The beneficiary Member State has requested funding of EUR 100 000 000, with first disbursement of EUR 20 000 000.

3. Compliance with the conditions for priority investment

- a) The beneficiary Member State has demonstrated that the investment complies with the requirements laid down in Article 10d(1) of the ETS Directive as it supports the modernisation of the energy system and it is in line with the objectives and measures set out in its NECP.
 - b) According to the information provided by the beneficiary Member State and pursuant to Article 10d(2) Directive 2003/87/EC, the investment is considered as a priority investment as it falls under the priority area “generation and use of electricity from renewable sources” and “the improvement of energy efficiency”.
 - c) The beneficiary Member State has sufficient funds available for the requested disbursement according to the statement of the available funds referred to in Article 5(1) of the Implementing Regulation and after deduction of any amounts to be disbursed for investments already confirmed in accordance with Article 6(9) of the Implementing Regulation.
- a) The beneficiary Member State has provided evidence that the projects under the investment proposal are exempted from the State aid notification in accordance with Commission Regulation (EU) No 651/2014 of 17 June 2014 declaring certain categories of aid compatible with the internal market in application of Articles 107 and 108 of the Treaty.
 - b) The beneficiary Member State has confirmed in writing that the investment complies with any other applicable requirements of Union and national law.
 - c) According to the information provided by the beneficiary Member State, the amounts requested from the Modernisation Fund are not intended to cover the same costs of the investment as those financed by another Union or national instrument.

4. Conclusions

The EIB has assessed the investment proposal based on the information submitted by the beneficiary Member State in accordance with Article 4 and Annex 1 of the Implementing Regulation and it has concluded that the investment proposal has met the conditions specified in Article 6(7) of the Implementing Regulation.

In view of the above, and in reliance on the information and evidence provided and the confirmations given by the beneficiary Member State, as described in paragraph 3 above, the EIB confirms the proposal “Financial instrument for improving energy efficiency in business (ENERG Programme)” (MF 2022-2 CZ 0-003) as a priority investment.

This confirmation, being based in part upon an exemption from State aid notification that is limited in time, is made on the assumption that the investment proposal, if it constitutes State aid after the expiry of such time limit, will continue to be exempted from State aid notification or that the beneficiary Member State will either obtain State aid clearance or cease to finance the investment proposal with Modernisation Fund funds at that time. As implied by Article 6(8) of the Implementing Regulation, the beneficiary Member State, when submitting a proposal concerning a subsequent disbursement for the scheme, may propose changes to the scheme for re-assessment.

This confirmation is without prejudice to the requirement for a disbursement decision to be made pursuant to Article 10d(3) of the ETS Directive.
