Investment Proposal: Investment in PV by public municipal waste service providers

1. Background

The Modernisation Fund was set up pursuant to Article 10d of Directive 2003/87/EC of the European Parliament and of the Council of 13 October 2003 establishing a system for greenhouse gas emission allowance trading within the Union and amending Council Directive 96/61/EC (the “ETS Directive”).

The legal basis for the operation of the Modernisation Fund is set out in the Commission Implementing Regulation (EU) 2020/1001 of 9 July 2020 laying down detailed rules for the application of Directive 2003/87/EC of the European Parliament and of the Council as regards the operation of the Modernisation Fund supporting investments to modernise the energy systems and to improve energy efficiency of certain Member States (the “Implementing Regulation”).

In accordance with Article 10d(6) of the ETS Directive, the European Investment Bank (the “EIB”) is to confirm whether a proposed investment falls into a priority area. The EIB may confirm the proposal as a priority investment if the conditions specified in Article 6(7) of the Implementing Regulation are met.

After the European Commission has decided on the first disbursement to the scheme, any subsequent disbursement shall require a separate proposal from the beneficiary Member State specifying the amount to be disbursed and containing the updated information about the scheme, as appropriate.

In accordance with Article 6(8) of the Implementing Regulation, where a proposal concerns a subsequent disbursement for a scheme confirmed by the EIB in accordance with Article 6(9) of the Implementing Regulation prior to the first disbursement and there have been no changes to the scheme, the EIB may confirm the proposal as a priority investment provided that the following conditions are met:

- a) the beneficiary Member State has sufficient funds available in the relevant category or subcategory of funds according to the statement of the available funds referred to in Article 5(1) of the Implementing Regulation and after deduction of any amounts to be disbursed for investments already confirmed in accordance with paragraph 9 of this Article 6(9) of the Implementing Regulation;
- b) the beneficiary Member State has provided evidence that the investment proposal fulfils either of the following requirements:
 - is exempted from the State aid notification in accordance with the applicable State aid rules;
- c) the beneficiary Member State has demonstrated that the investment complies with Article 10f of Directive 2003/87/EC, where needed;
- d) the beneficiary Member State provides information about the implementation of the scheme in accordance with Annex I, point 4.2.

2. *Investment proposal*

Pursuant to Article 4(2) (second sentence) of the Implementing Regulation, on 06/02/2024 the BMS (the “beneficiary Member State”) submitted to the EIB an investment proposal concerning a subsequent disbursement from the Modernisation Fund for the “Investment in PV by public municipal waste service providers”, (Modernisation Fund reference number MF 2024-1 HR 0-002).

The investment scheme “Investment in PV by public municipal waste service providers” was confirmed as a priority investment proposal by the EIB on 15/03/2023 (Modernisation Fund reference number MF 2023-1 HR 0-004).

The European Commission issued Decision C(2023) 3643 on the first disbursement of the revenues of the Modernisation Fund under Directive 2003/87/EC on 30 May 2023.

The EIB has already disbursed an amount of EUR 5 000 000 of the revenues of the Modernisation Fund.

The beneficiary Member State has requested funding of EUR 5 000 000 for a subsequent disbursement under the investment proposal.

The beneficiary Member State has indicated an expected Modernisation Fund funding for the scheme of EUR 10 000 000.

3. Compliance with the conditions for priority investment

- a) The beneficiary Member State has confirmed that there have been no changes to the scheme.
- b) The beneficiary Member State has sufficient funds generated before 31 December 2027 available from the auctioning of allowances referred in Article 10(1), the third subparagraph of Directive 2003/87/EC - 2% for the requested disbursement according to the statement of the available funds referred to in Article 5(1) of the Implementing Regulation and after deduction of any amounts to be disbursed for investments already confirmed in accordance with Article 6(9) of the Implementing Regulation.
- c) The beneficiary Member State has provided evidence that the investment proposal obtained State aid clearance in accordance with the Commission decision.
- d) The beneficiary Member State has provided information about the status of implementation of the scheme in accordance with Annex I, point 4.2a of the Implementing Regulation.

4. Conclusions

The EIB has assessed the subsequent disbursement proposal based on the information submitted by the beneficiary Member State in accordance with Article 4(2) (second sentence) of the Implementing Regulation. Given the beneficiary Member State has confirmed there have been no changes to the scheme,

and:

- a) the beneficiary Member State has declared that there are no changes to the evidence of State aid compliance of the scheme,
- b) the beneficiary Member State has provided information about the implementation of the scheme in accordance with Annex I, point 4.2,

the EIB's assessment is limited to the verification of available funds as set out in Article 6(8) of the Implementing Regulation. EIB confirms that sufficient funds are available for the disbursement requested. In view of the above, and in reliance on the information and evidence provided and the confirmations given by the beneficiary Member State as described at paragraph 3 above, the EIB confirms the subsequent disbursement of EUR 5 000 000 for the priority scheme "Investment in PV by public municipal waste service providers", (Modernisation Fund reference number MF 2024-1 HR 0-002).

This confirmation, being based in part upon an exemption from State aid notification that is limited in time, is made on the assumption that the investment proposal, if it constitutes State aid after the expiry of such time limit, will continue to be exempted from State aid notification or that the beneficiary Member State will either obtain State

aid clearance or cease to finance the investment proposal with Modernisation Fund funds at that time.

This confirmation is without prejudice to the requirement for a disbursement decision to be made pursuant to Article 10d(3) of the ETS Directive.
